2.1. Classification of the mixture:

- **Biological hazards:**
 - **Biosafety Level 1 Cell Cultures:** Handle as potentially biohazardous under Biosafety Level 1 containment. Although not known to cause disease in healthy humans, this cannot be excluded. Frozen or growing cells are shipped in a yellow or pink liquid cell culture medium (pH 6-8) containing inorganic salts, vitamins, amino acids, carbohydrates, other nutrients, and phenol red dissolved in water. Frozen cultures may also contain 5-10% DMSO as a cryoprotectant.
- **Unit:** Cryovial (frozen liquid in a small plastic container) or flask (living cell culture in a plastic flask).
