Section 2: Hazards identification

2.1. Classification of the mixture:

- **Biological hazards:**
 - **Biosafety Level 1 Cell Cultures:** Handle as potentially biohazardous under Biosafety Level 1 containment. Although not known to cause disease in healthy humans, this cannot be excluded. The material has not been screened for Hepatitis B, HIV, or other adventitious agents unless stated on the Certificate of Analysis or product information sheet. Use personal protective equipment (PPE) as necessary.
 - **Biosafety Level 2 Cell Cultures:** Handle as potentially biohazardous under Biosafety Level 2 containment. This material is virally transformed or contains Epstein-Barr-Virus particles, which may be associated with human disease. Hazards include percutaneous injury, ingestion, and mucous membrane exposure. - **Description:** Various animal and human cell cultures at Biosafety Level 1 or 2. Frozen or growing cells are shipped in a yellow or pink liquid cell culture medium (pH 6-8) containing inorganic salts, vitamins, amino acids, carbohydrates, other nutrients, and phenol red dissolved in water. Frozen cultures may also contain 5-10% DMSO as a cryoprotectant.
- **Unit:** Cryovial (frozen liquid in a small plastic container) or flask (living cell culture in a plastic flask).

8.2. Exposure controls:
