### 2.1. Classification of the mixture:

- **Biological hazards:**
  - **Biosafety Level 1 Cell Cultures:** Handle as potentially biohazardous under Biosafety Level 1 containment. Although not known to cause disease in healthy humans, this cannot be excluded. Frozen cultures may also contain 5-10% DMSO as a cryoprotectant.
